

Dr. Grant Garrigues-Shoulder and Elbow Surgical Durable Medical Equipment (DME)

Medically Necessary Equipment: *(Delivery not available to Elmhurst or Rush University Medical Center)*

Shoulder Procedures

- **Abduction Sling:** This is used for immobilization and/or support following most shoulder procedures and will be adjusted to fit you at your surgical location and billed to your insurance. (Delivery not available to Elmhurst Hospital or RUSH University Medical Center-Sling must be picked up in a DME Store prior to surgery).
- **Standard Velcro Arm Sling:** This is utilized for less invasive/non-shoulder repair procedures. It will be adjusted to fit at your surgical location and billed to your insurance.



Elbow Procedures

- **Postoperative Hinged Elbow Brace:** This is utilized to limit motion and protect the repair site following some elbow repair surgeries. Patients will be sent to a DME Store following their first postoperative appointment (Approximately 10-14 days after surgery) to receive the brace.



Optional Medical Equipment:

(Delivery not available to Elmhurst or Rush University Medical Center)

Breg Polar Care Wave Ice Machine:

Provides constant cooling and intermittent compression to the shoulder. This product is not billed to private insurance and must be paid for at least one business day prior to surgery to allow time for delivery to your surgery location.



Cold Water Circulating Ice Machine:

Provides constant cooling with ice water from unit to the shoulder. This product is not billed to private insurance and must be paid for at least one business day prior to surgery to allow time for delivery to your surgery location.



Gel Ice Wrap (large and small available based on procedure):

The product wraps around your shoulder or elbow and is used for 20–30-minute icing sessions every hour as needed. This is an alternative to an ice machine that is available at some surgical locations and can be billed to your insurance *(excluding Medicare)*. If you do not wish to receive this product, please 'Refuse' it on documentation presented to you at time of check-in to surgery.
